

In exercise of the powers conferred under Section 2 of the Epidemic Diseases Act, 1897 and the powers, conferred under The Disaster Management Act, 2005, the undersigned, in his capacity of Incident Commander Pune Cantonment Board, hereby issues the following directions, that will remain in force throughout the limits of Pune Cantonment from 8PM on 20th April, 2021 till 7 AM on 1st, May, 2021.

1. All Groceries, Vegetables Shops, fruit vendors, dairies, bakeries, confectionaries, all type of food shops (including chicken, mutton, poultry, fish and eggs), shops related to agricultural implements and farm produce, pet food shops, shops related to materials for impending rainy season for individuals as well as for organizations to be open only between 7 AM to 11 AM.
2. Home delivery from the said shops however may be allowed between 7.00 AM to 6.00 PM.
3. All other conditions other than the ones specified in this order will be in accordance with the Pune Cantonment Board Order dated 15th

April, 2021.

All the orders mentioned above will be applicable till further order.
